## NOTIFICATION

No.LD 323 LSI 2010, Bangalore, Dated:16.03.2011

Whereas the draft to extend the provisions of ESI Act 1948 to the classes of establishments specified in the schedule annexed to the draft was published in Karnataka Gazette on 13.01.2011 in Notification No.LD 323 LSI 2010, Dated:06.12.2010 inviting objections and suggestions from persons likely to be affected thereby with in one month from the date of publication in the official Gazette.

And whereas the said Gazette was made available to the public on 13.01.2011,

And whereas, no objection and suggestions have been received from any persons within the specified period.

Now, therefore, in exercise of the powers conferred under Sub Section (5) of Section 1 of Employees State Insurance Act 1948, the Government of Karnataka hereby extends the provisions of the Act to the classes of establishments specified in the schedule annexed here to;
