**Terms and Conditions: - (scope of work)**

1. The service provider shall quote his lump sum comprehensive service charges including spares per number of item on visit basis including tax for the items enlisted above in separate cover.
2. The AMC/CMC service provider should visit the hospital once in a quarter for preventive maintenance and on all break down calls to repair the out of order items. Response time should be 24 Hours and Repair should be done with in 48 Hours.
3. In case of Labour AMC cost of routinely used spares with cost list should be given. In case of CMC list of exclusives should be given.
4. In case the item has to be taken to work shop for repair, prior permission and sanction for fixed transportation charges shall be taken. The firm will deposit security deposit as demanded by the hospital before taking out the item from hospital. In case repair is likely to take more than 48 Hours, a Standby equipment is to be provided free of cost.

5. The repair work should be completed & the item returned immediately and in any case within 3 days.
6. Warranty of at least 3 months to be given for the repairs carried out in respect of each item.
7. Application & documents form fees of Rs.200/- non – refundable payable in person by crossed Banker’s Cheque/ DD in favour of ESIC A/C No.1, payable at Bangalore along with application.
8. EMD: Tenderer should enclose EMD for each item by way of DD/Banker’s Cheque payable at SBI, Bangalore – 560 001, in favour of ESIC A/C No.1, EMD of unsuccessful tenderer will be returned without interest & after the contract is finalized.
9. EMD of the successful tenderer will be refunded after entry into the contract and giving performance guarantee.
10. **Performance guarantee deposit:** - The successful tender shall immediately deposit performance guarantee deposit of appropriate amount for the item tendered as shown above. The same will be returned after three months of completion of AMC/CMC.
11. Date for issue of tender documents **19.08.2010 to 02.09.10 from 09 a.m. up to 3.p.m.**
12. Last date for receipt of completed documents **03.09.2010 up to 1.00.p.m.** or if it happens to be holiday on next working day.
13. Tender will be opened in presence of representatives present on **03.09.2010 at 3.00p.m.** in conference hall of this hospital. If the same happens to be declared holiday then as next working day at same time & place.
14. Breach of any terms & conditions attracts penalty by way of forfeiture of EMD or security deposit.
15. Transportation charges if item is to be taken out to working should be quoted separately.
16. Application forms may also be downloaded from website [www.esic.kar.in](http://www.esic.kar.in) and the fee to enclose by DD drawn in favour of ESIC A/C No.1, payable at Bangalore.
17. Medical Superintendent of ESIC Model Hospital reserves right to accept or reject postpone the dates or cancel any or all the tenders without assigning any reason what so ever.

18. The contract shall be initially for one year extendable thereafter on mutual agreement at same rate terms & conditions.
19. **Arbitration & Jurisprudence:** - In case of any dispute the same will be arbitrated by Medical Superintendent. Any dispute not followed by arbitration shall be subject to Bangalore Jurisprudence.
20. **Service tax to be quoted separately.**
21. Payment will be paid in 2 equal installments. One at the time of entering into contract and the other after satisfactory completion of AMC period.
22. Four Preventive Maintenance visits service and all break down calls.
